

IMPORTANT NOTICE TO HEALTH PLAN PARTICIPANTS

Special Enrollment Right for Employees with Medicaid Health Coverage or Dependent Coverage under the Child Health Insurance Program.

The government requires Oxy to notify you that if you have health coverage under Medicaid, or your dependent has health coverage under the Child health Insurance Program (CHIP), and that coverage is terminated because you are or your dependent is no longer eligible, you or your dependent may request coverage under Oxy's health plan within 60 days of such termination of coverage, rather than the 31 days that is normally required upon loss of health coverage.

If you become or your dependents becomes eligible for Medicaid or financial assistance under CHIP, you or your dependent may request coverage under Oxy's health plan within 60 days, rather than 31 days, after your eligibility determination date.

In addition, under CHIP, financial assistance may be available if you meet your State programs's eligibility requirements. For additional information regarding premium, assistance subsidies, see the attached Notice.

Premium Assistance Under Medicaid and the Children's Health Insurance Program (CHIP)

If you or your children are eligible for Medicaid or CHIP and you're eligible for health coverage from your employer, your state may have a premium assistance program that can help pay for coverage, using funds from their Medicaid or CHIP programs. If you or your children aren't eligible for Medicaid or CHIP, you won't be eligible for these premium assistance programs but you may be able to buy individual insurance coverage through the Health Insurance Marketplace. For more information, visit www.healthcare.gov.

If you or your dependents are already enrolled in Medicaid or CHIP and you live in a State listed below, contact your State Medicaid or CHIP office to find out if premium assistance is available.

If you or your dependents are NOT currently enrolled in Medicaid or CHIP, and you think you or any of your dependents might be eligible for either of these programs, contact your State Medicaid or CHIP office or dial **1-877-KIDS NOW** or www.insurekidsnow.gov to find out how to apply. If you qualify, ask your state if it has a program that might help you pay the premiums for an employer-sponsored plan.

If you or your dependents are eligible for premium assistance under Medicaid or CHIP, as well as eligible under your employer plan, your employer must allow you to enroll in your employer plan if you aren't already enrolled. This is called a "special enrollment" opportunity, and **you must request coverage within 60 days of being determined eligible for premium assistance**. Paperwork Reduction Act Statement

According to the Paperwork Reduction Act of 1995 (Pub.
