

**SUMMARY ANNUAL REPORT  
FOR  
OCCIDENTAL PETROLEUM CORPORATION SAVINGS PLAN**

This is a summary of the annual report for the Occidental Petroleum Corporation Savings Plan, EIN 95-4035997, Plan No. 001, for the period January 1, 2021 through December 31, 2021. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

**Basic Financial Statement**

Benefits under the plan are provided by a trust fund. Plan expenses were \$215,088,882. These expenses included \$1,995,989 in administrative expenses and \$213,092,893 in benefits paid to participants and beneficiaries. A total of 12,136 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$2,801,006,072 as of December 31, 2021, compared to \$2,339,450,098 as of January 1, 2021. During the plan year, the plan experienced an increase in its net assets of \$461,555,974. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$676,644,856 including employer contributions of \$70,892,589, employee contributions which includes employee rollovers of \$109,471,120, earnings from investments of \$496,281,147.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of the report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan (Occidental Petroleum Corporation, 5 Greenway Plaza, Houston, TX 77046-0506) and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
